The Substitution  $U = 1+x^2$  We Get  $\int \sqrt{1+x^2} 2x dx = \int \sqrt{U} 2x dx = \int \sqrt{U} U du = \frac{2}{3} U^{3/2} + C = \frac{2}{3} (1+x^2)^{3/2} + C$ .
